It is decided to conduct the 114th Annual General Body meeting and election of the Office bearers Of SNDP Yogam Kollam on 5th February 2022 at 10 am at Cherthala S.N.College campus presided by Yogam President Dr.M.N.Soman, based on the orders of the Kerala Disaster Management (A) Department vide G.O (Rt) No 875/2021DMD dtd 29-12-2021 and G.O (Rt) No 877/2021 DMD dtd 30-12-2021, issued as per the directions of the Hon'ble High Court Of Kerala in W.P (C) No.30628/2021 dtd 23-12-2021, which was formerly decided to be conducted on Saturday 22nd May 2021 Saturday, at Cherthala S.N.College Auditorium but adjourned due to the wide spread of Covid -19 pandemic as well by the order of the Government of Kerala as per the directions of The Hon'ble High Court of Kerala in W.P (c) No.10796/2021 dtd 14-05-2021. It is also decided to conduct the Annual General Body via video conferencing /audio visual connection and secret voting for election of Office Bearers at Cherthala S.N.College campus and various polling stations mentioned in the schedule here under via electronic media and paper ballot methods, All the delegates of the General Body, as per Clause 44 of Yogam ByeLaw, are hereby informed to participate in the Annual General Body meeting and election of the Office bearers Of SNDP Yogam.

ELECTION PROGRAMME

Notice dtd 22-04-2021 was published in the newspapers dtd 24-04-2021. Based on that a draft voters list was published on 26-04-2021 at Yogam Office and objections against draft voters list were received dated 28-04-2021 and on 29-04-2021 the Yogam Council considered the objections and published final voters list on 30-04-2021. On 06-05-2021 the nominations were submitted before the Returning Officer and scrutinizing the nominations on 07-05-2021, the Returning Officer had published the list of eligible candidates at 5.00 pm on 07-05-2021. The appeals against the decision of the Returning Officer were filed on 09-05-2021 and the said appeals were disposed by the Yogam Council on 12-05-2021 and a list of eligible candidates was published on 12-05-2021 at 5pm. Several candidates withdrew their candidature on 14-05-2021 and on the same day, by evening, the final list of candidates was published. The rest of the adjourned proceedings mentioned in the earlier notification will be conducted at relevant Centres according to the programs mentioned below.

1. Election - 05-02-2022 11am to 6.00 pm
2. Counting - 05-02-2022 6.30 pm onwards
3. Publishing the result As and when counting is over

- NB: 1) Those who intend to present any resolution in the General Body Meeting should sent the same as if to reach the office of the General Secretary prior to 7 days of General Body Meeting or through the website mentioned herewith. email ID : office@sndpyogam.co.in
- 2) The annual general body representatives alone can participate in the meeting.
- 3) The election to the post of Yogam President, Vice President, General Secretary, Devaswom Secretary will be conducted as per the provisions of Yogam and Company Election Rules via electronic media and secret ballot voting systems. Hon'ble District and Sessions Judge (Retd) and Former Law Secretary to Government of Kerala, Sri B.G.Harindranath had been appointed as Returning Officer of SNDP Yogam Election.
- 4) There will be provision for casting votes of the representatives of Annual General Body at meeting/polling Centres via electronic media or paper ballot systems and both the means of voting will be safe and secretive.
- 5) The representative of Annual General Body meeting who wish to cast vote via e-voting system must inform the returning officer of the yogam election not earlier than seven days before the Annual General Body.
- 6) The voters shall enter the General Body Meeting hall by showing the meeting representative pass and identity card. Such as election id, adhaar card, passport or driving license.
- 7) Those who are to be appointed as Yogam Directors shall submit the DIN or any other number allotted as per Company Law along with a declaration that such person is not ineligible to be appointed as Director and also a consent letter to be appointed as Director.
- 8) The pass of representatives required for entering the meeting hall, attending Annual General Body meeting will be available from Cherthala S.N. College, from General Secretary, and that of the present and former office bearers and director board members from the concerned meeting place and from those mentioned in the 4th column of the schedule and as authorized by the Board under the supervision of respective returning officers. The pass of the representatives of Sakhas and Unions, Union Councilors, representatives of Yogam AGM has to be collected directly by Union Secretaries from respective meeting places and distributed among the representatives. If the Union Secretary is not available, the person authorized by him on production of the authorization letter shall do the same. (The Yogam Directors, Union Presidents, Vice Presidents and Union Secretaries shall collect their pass from their respective places). The entry to the meeting hall will commence from 9am.
- 10) The final voters list, Serial number and candidate list of each Centre will be published in advance at respective Centres mentioned in the schedule attached.
- 11) In order to strictly abide the Covid protocols and Government orders the Asst Returning Officers of each Centre shall issue electoral slips to the voters with time slots according to the serial number.
- 12) As per the order of the Kochi National Law Tribunal in C.A No 39/2021 in C.P 51/KOB permitting the conduct of Yogam Annual General Body Meeting and election, all decisions of Annual General Body Meeting will be subject to the final judgment in C.P 51/KOB/2020, C.P 42/KOB/2020 and C.P 50/KOB/2020.

- 3) Those delegates who haven't yet registered their email id shall register it through office@sndpyogam.co.in
- 4) The member who cast his e-vote before the commencement of Annual General Body Meeting can though participate in the meeting, will not be allowed to cast their vote again.

The instructions for members voting electronically are as under :

- The voting period begins on 2.02.2022, at 10Am and ends on 4.02.2022 at 5 PM [IST]. The e-voting module shall be disabled for voting thereafter.
- The Members should log on to the e-voting website www.evotingindia.com.
- Click on Shareholders/members you will be redirected to E voting login page.
- Enter your User ID followed by the Verification Code displayed.
- User ID will be your Member ID
- Enter your password XXXXXXXX. Password will send by CDSL to the email id /mobile number provided to the presiding officer through Form
- After entering these details appropriately, click on "SUBMIT" tab.
- Upon successfully login to the E-voting Login Page, Click on the Electronic Voting Sequence Number (EVSN) for the relevant company on which you choose to vote
- On the voting page, you will see photographs of the Nominees for the post and to select candidate click on photograph of the Candidate. if you want to deselect again click in the photograph
- After selecting the candidate click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- Once you "CONFIRM" your vote on the Candidate, you will not be allowed to modify your vote.
- After submit, the next Post E voting page will be display for voting
- For Voting on Resolutions Click on the Electronic Voting Sequence Number (EVSN) for the relevant company on which you choose to vote
- On the voting page, you will see "RESOLUTION DESCRIPTION" and against the same the option "YES/NO" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- Click on the "RESOLUTIONS FILE LINK" if you wish to view the entire Resolution details.
- After selecting the resolution, you have decided to vote on, click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- Once you "CONFIRM" your vote on the resolution, you will not be allowed to modify your vote.
